Period Ended 31st December 2002

Summary of Significant Accounting Policies

- 1 The accompanying financial statements have been prepared in accordance with the requirements of the Federation's statutes.
- 2 Translation of foreign currencies.
The Statements of accounts are in Swiss currency, foreign currencies are translated into Swiss francs as follows:

Current assets and current liabilities - rate prevailing at the end of the period under review.

Income and Expenses are calculated at current rate.

- 3 Debtors are stated at nominal value, net of provision for bad debts, which covers all members in arrears in fulfilment of their financial obligations to FIDE, temporarily excluded or to be excluded as per FIDE statutes (A.01, page 4, rule 2.5).
- 4 Stocks of medals have been written down to a nominal value of CHF1. They have no intrinsic value outside FIDE.
- 5 Depreciation rate of 30% per annum on outstanding balance.
- 6 Provision has been made for ex gratia payments due to staff under terms of their employment.
