- Bid Fees are not refundable. Bid fees should be paid the latest by 28<sup>th</sup> July 2023 to the FIDE bank account (net of transfer or bank charges), or to be enclosed in the bid envelope.
- Within a month after being awarded FIDE Chess Championships 2024, the
  organising member federation shall pay deposit fee to FIDE. When the event has
  been successfully concluded (according to the bid and the regulations), the
  deposit fee shall be credited to the account of the organising federation or
  refunded.

# THE BIDDING FEDERATION'S RESPONSIBILITIES:

- All bidders must fill in the bid form and the bid form annex completely (with no empty boxes)
- The bidding federations are responsible for providing high resolution photo & video descriptions of:
  - 1. The playing area with its full lighting
  - 2. Other areas in the playing venue, including toilet facilities
  - 3. Hotel rooms standard, deluxe and suites
- The bidding federations shall pay special attention to the information about:
  - 1. Dimensions of playing area/areas
  - 2. Names of the hotels, dimensions of the types of hotel rooms, and the number of rooms in each hotel
  - 3. Rates of single, double, triple and family rooms in each hotel
  - 4. Number of boards for live transmission
  - 5. Parallel activities
  - 6. The food selection during breakfast, lunch and dinner (general menu for each meal with sufficient selection of main dishes, side dishes, starters, desserts and fruits)

If the above-mentioned information is not provided, the bid will not be considered.

## **BID FORM BID FORM ANNEX**

- EVE will make inspections. The first inspection will be within two months after the bid deadline. The second inspection will be two to four months prior to the event. Accommodation and local transfer costs of the inspections must be paid by the organisers.
- FIDE Officials: Appeals Committee, Chief Arbiter, Deputy Chief Arbiters and Fair Play Arbiters will be decided and appointed by FIDE.
- FIDE Technical Delegate will be appointed by EVE by the approval of FIDE President.
- All bidders must ensure the tournaments are played in accordance with the regulations which are current at the time of the event (where available, the present regulations are provided for reference below):
