FIDE Trainers' Commission (TRG) 21st Telemeeting (05.09.2011) Minutes & Decisions

1. Applications for Trainers: We received a relevant application (attached TRG-01-Application) by the:

1.1. Denmark Chess Federation: FIDE Senior Trainer: Jacob Aagaard.

TRG voted as according to rules and accepted the above application.

TRG also received letters by:

1. USCF (W.Browne) and FIDE Vice President Beatriz Marinello (attached TRG-02-Marinello 1 & 2). In these letters/applications it is explained that the applicant attended a FIDE seminar in Phoenix 2005, conducted by FST (and nowadays) TRG Councilor M.Khodarkovsky. For internal reasons the name of B.Marinello was omitted in the then official results.

2. Myanmar CF and Maung Maung Lwin (attached TRG-02-Maung). For unknown reasons the name was omitted in the 2005 direct approval process by the then TRG Council.

TRG accepted the applications on the following terms:

- 1. Marinello Beatriz:
- a. The title of FT will count as a 2005-awarded year by a seminar result.
- b. The FIDE seminar fee of 100 euros will be paid.
- c. The FIDE title fee of 200 euros will be paid.
- d. The FIDE licence fee (2011-2014) of 120 euros will be paid.
- 2. Maung Maung Lwin:
- a. The title of FT will count as a 2005-direct awarded year.
- b. The FIDE title fee of 200 euros will be paid.
- c. The FIDE licence fee (2011-2014) of 120 euros will be paid.

The Secretary will inform FIDE office on the procedures and the titles awarded (attached TRG-03-New Titles) will be valid when approved by the next EB but they are counting by the date of approval by the TRG Council.

2. Seminars: The Council worked on future seminars as follows:

The Council approved the Prospectus and the final results of the New York (US America * 27-28.06.2011 * M.Khodarkovsky-S.Palatnik) seminar (attached TRG-04-FTS-USA 2011-Prospectus).

The Council approved the Prospectus and the final results of the Bangkok (Thailand * 01-06.08.2011 * NI Alberto Muniz (ESP) assisted for Thai language translation by Maung Maung Lwin (MYA)) ACA seminar (attached TRG-04-FTS-THA-VIE 2011).

The Council approved the Prospectus and the final results of the Binh Duong (Vietnam * 03-10.08.2011 * FT Eric Gloria (PHI) assisted for Vietnamese language by FT Luong Trong Minh (VIE)) ACA (attached TRG-04-FTS-THA-VIE 2011).

In the above two seminars the DI title will be awarded - there will be no seminar fees.

The Council approved the Prospectus of the Lima (Peru * 03-06.11.2011 * FT Martha Fierro) seminar (attached TRG-04-FTS-PER 2011-Application & Approval & Prospectus).

For the Germany/Berlin seminar (16-1.12.2011 * U.Boensch) the Council decided, although it is not allowed in general FT titles for 15-hour seminars, that for TRG's oldest Academy it can be allowed 3 FT titles, as an exception.

3. Financial: The Council approved the 2011 4-a Quarter TRG expenses (attached TRG-05-Budget 2011-Quarter 4a). There will be another 4-b Quarter expenses letter, dealing with financial matters by 31.12.2011.

4. English CF Certificate of Merit: The Council received a letter from Stewart Rueben (attached TRG-06-ECF Merit) which describes a certain idea of promoting diplomas by ECF (www.certificateofmerit.org.uk). Mr. S.Rueben proposed to TRG to deal with it as well, but TRG's purposes are not directed on promoting diplomas but rather on educating and certifying trainers all around the world. For these reasons TRG decided that cannot deal with this project.

5. Emmanuel Chess Centre: We received an invitation for a workshop by the Emmanuel Chess Centre in India, directed by FT Joseph Ebenezer. As this centre is using FIDE logo and TRG Guide without authorization, TRG sent a letter of clarification (attached TRG-07-ECC-India 1 & 2 and TRG-07-Invite CTW2 1 & 2 & 3 & 4).

6. Various: Council's members were generally informed by the Secretary and discussed various subjects concerning training subjects.

All Council's decisions/proposals will come in force after the next EB approval.

The present Minutes will be announced on TRG' website. The attached letters will not be announced till their approval by the next EB.
