5. Hosting Country

5.1 South Africa



As day breaks over Africa and the sun spreads its warm glow over the land in vibrant colours, accompanied by the hum of the cicadas, energetically beating their wings in time to the pounding of ancient drums from days gone by.

South Africa; a land of passion and creativity.....

South Africa is celebrating 20 years of democracy and invites all participants of the WYCC to celebrate this wonderful achievement with us. The Rainbow Nation as its inhabitants are often called, with its diversity of Cultures and languages are the ingredients for an unforgettable experience.

Situated at the southern tip of Africa, it is edged on three sides by nearly 3000 km of coastline, with the Indian Ocean to the east and the Atlantic Ocean to the west.

South Africa is a multilingual country and although there are 11 official languages English is the language most widely understood, and is the second language of the majority of South Africans.



5.2 The Zulu Kingdom



From the majestic Drakensberg Mountains to the sparkling Indian Ocean: Peaceful, green hills, waving grasslands, abundant forests, white deserted beaches, rugged cliffs, unhurried lifestyle and smiling people. This is truly the land of beauty and splendour.

A soil imbued with the strength of the Zulu nation who fought for this land.

5.3 Hosting City – Durban



Durban is the largest city in the South African province of KwaZulu-Natal, also tenderly known as the Zulu Kingdom. Durban is also the major centre of tourism in South Africa because of the city's warm subtropical climate and extensive beaches.

Durban is renowned for its magnificent bathing and surfing beaches, which stretch along the city's beachfront from Durban harbour in the south to the upmarket suburb of Umhlanga in the north.

An expansive paved promenade offers access to the best of these beaches – the Golden Mile – where joggers, cyclists, dog owners, surfers, body boarders and walkers enjoy early-morning and late-afternoon exercise.

Culturally, Durban exhibits a mix of Indian, Zulu and post-colonial influences, reflected in the city's architecture and cuisine. Curries, seafood and fusion food are popular at beachfront restaurants, Wilson's Wharf, at the gourmet hot spots and coffee shops that line Florida- and Helen Joseph Road.

Shopping is best enjoyed at Durban's out-of-city malls: the Gateway Theatre of Shopping in Umhlanga; the Pavilion in Westville; and the Galleria in Amanzimtoti. An overwhelming choice of shops in air-conditioned comfort makes spending money a most enjoyable pursuit.

Half an hour inland from the city, the Valley of a Thousand Hills promises a taste of African culture, while further into the countryside the Midlands Meander features about 150 art-and-craft outlets for city-dwellers in search of fresh air and home-made fare.

Adventure activities are well catered for in and around this coastal city, with deep-sea fishing charters, dolphin viewing, jet-skiing, shark cage-diving, quad biking, scuba diving, hiking, mountain biking, canoeing, boat cruises and much more readily available.

5.4 Venue



The Championships will be hosted at the International Convention Centre, Durban, Kwa-Zulu Natal, South Africa. The ICC Durban is one of the most advanced conference facilities in the world. The facility boasts the largest area of column free, flat floor, multi-purpose space in Africa coupled with state of the art technology. As well as being named Africa's Leading Conference Centre for the 10th year by the World Travel Awards, the ICC Durban has been voted amongst the top 20 conference centres in the world by the AIPC.

The ICC Durban is purpose-built, fully air-conditioned and comprises six convention halls that are interlinked, but separate. Halls 4-6 double as convention and meetings spaces and the flat floor space for the ICC Arena makes it the leading indoor sports and entertainment venue in Durban which accommodates up to 10 000 spectators.



The ICC Arena has full technical capacity for live broadcasts as well as house lighting suitable for TV production filming. There are two on-site generators which can fully power the centre in the event of power disruptions.

Operable walls allow for venue flexibility, catering for plenary seating of up to 12300 delegates and raked seating for 3880 delegates. There are three outdoor courtyard venues of over 1 000m². In addition, the facility boasts up to 25 meeting rooms ranging from 43m² to 396m².

Within the ICC Durban there is a Business Complex which includes banking and foreign exchange facilities, medical services, stationery and postal services.

The ICC Durban is disabled-friendly, with international standard wheel-chair access, designated drop-off points and parking bays, toilets for the physically disabled, and a Braille route through the centre and elevators.

6.3 Internal Travel

6.3.1 Airport Shuttle service

A regular shuttle service from King Shaka International to the venue on 19 September 2014 and back to King Shaka from the Hotels on 30 September 2014. A shuttle service will provide transport to and from the Hotels and the ICC.

6.3.2 Hotel Shuttle service

Daily shuttles will run to and from the venue, Shuttles will run in 30 minute intervals from the ICC to the hotels after 60minutes after the start of the round.

6.4 Visas

1. All visiting players, officials and accompanying persons are responsible ensuring that their travel documents are in order before departing for South Africa.

Since this list is "subject to change" without notice it is best to check with the South African Embassy in your country regarding the current status.

6.5 Yellow fever vaccination

1. As of 1 October 2011, South Africa requires all travellers journeying from yellow fever risk countries to show proof of yellow fever vaccination by means of a valid yellow fever certificate.
2. The vaccination should be administered at a yellow fever approved vaccination centre at least 10 days before departure to South Africa, as the vaccine only offers protection 10 days after administration.
3. Failure to produce a valid yellow fever vaccination certificate at a South African port of entry could lead to refusal of entry.
4. Those who have an exemption certificate due to medical reasons will be allowed entry, but will be required to report any fever or other symptoms to the health authorities, and will be placed under surveillance.
5. Countries for which a yellow fever vaccination certificate is required for entry into South Africa are:



Angola, Argentina, Benin, Bolivia, Brazil, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Colombia, Guinea-Bissau, Congo, Côte d'Ivoire, Democratic Republic of the Congo, Ecuador, Equatorial Guinea, Ethiopia, French Guyana, Gabon, Gambia, Ghana, Guinea, Guyana, Kenya, Liberia, Mali, Mauritania, Niger, Nigeria, Panama, Paraguay, Peru, Rwanda, Sao Tome and Principe, Senegal, Sierra Leone, Somalia, Sudan, Suriname, Togo, Trinidad and Tobago, Uganda, United Republic of Tanzania, Venezuela, and Zambia. Please take special note of the requirement for Yellow Fever inoculation certificates for those travelling from the yellow fever belt of Africa and South America.

All participants including parents, coaches, observers and relatives are obliged to stay in official hotels.

1. All official accredited accommodation is on a full board basis, i.e. breakfast, lunch and dinner at hotels around the venue for all participants and accompanying persons for the account of the Federation. 4. The organisers will host a maximum of twelve (12) Official Players and one (1) accompanying Official (FIDE Trainer) per Federation on a full board basis, from the official date of arrival (19 September) to the official date of departure (30 September). This accommodation is on sharing basis.
5. People wishing to arrive before the official arrival date (19 September 2014) or depart after the official departure date (30 September 2014) for their own account, are welcome to do so provided they indicate this when registering. The LOC will, where possible, provide assistance should this be requested.
6. If a participating Federation does not send an official player in a specific age category, they cannot substitute this for a player in another age category.
7. All additional players, officials and accompanying persons from participating Federations will be accommodated at the various accredited hotels on a full board basis for their own account.
8. All accredited accommodation reservations must be made online via the Tournament Website and no direct reservations at these hotels will be allowed.

9. The deadline for the reservation and payment of a 50% deposit on the accommodation is 17 July 2014. Any accommodation payment made after the deadline, will incur a surcharge of 10%.
10. Once the payment has been made, proof of payment must be sent to the Treasurer at treasurer@2014wycc.co.za
11. As soon as the payment is confirmed the Organisers will send the Federation the confirmation of their hotel reservation.
12. All confirmed registrations will be loaded on the tournament website.
13. No player, Federation official or accompanying person will be allowed to check into any hotel unless the accommodation has been paid for in full before arrival.
14. No players will be paired until all the payments have been made in full to the organisers.

8. Administrative Regulations

8.1 Federation Representative

1. Please take note that we will only liaise with one representative per Federation or FIDE Academy. Kindly provide us with the full contact details of your authorized representative with whom we can deal on all matters.
2. Please ensure that the contact person has access to email and the internet as all correspondence will be by email and on the website.

8.2 Registration

1. All registrations must be done via the tournament website. This includes registering players, managers, coaches and accompanying persons etc.
2. Each participating Federation will be issued with an online registration id and password in order to access the online registration program.
3. The deadline for registration is 17 July 2014. A penalty of R1 500 (ZAR) per person will be charged for each late registration until 17 August 2014. After this date, the organizers reserve the right to refuse or decline any late registrations or charge double costs for participants. If a person pays a deposit and does not participate, this amount is not refundable.



1. All participants, officials, additional players, managers, coaches and spectators will receive an identification card with colour codes. The colours will indicate and allow access to certain areas. Any person not adhering to restrictions will be expelled from the event.
2. Name cards must be worn at all times.
3. Compulsory head-and-shoulders photograph must be send to the LOC for all participants, additional players, spectators, coaches and managers. The file name of the photo graph must be the name of the player.

8.7 Qualification

1. Each National Federation can register a total of twelve (12) Official Players, that is, one official player in each category (under 8, 10, 12, 14, 16, 18 years old; open and girls) plus one accompanying official, provided he/she holds a valid licence and title as a FIDE Trainer.
2. Age groups:
 - a. u/8: Players must be born in 2006 and later
 - b. u/10: Players must be born in 2004 and later
 - c. u/12: Players must be born in 2002 and later
 - d. u/14: Players must be born in 2000 and later
 - e. u/16: Players must be born in 1998 and later
 - f. u/18: Players must be born in 1996 and later
3. The players placed 1st to 3rd in the previous World Youth Championships, and the respective Champions of the 2014 Continental Youth Championships, shall have the personal rights to participate in the World Youth Championships of the corresponding age-category or a higher age-category if the age stipulation of clause 7.7.2 above is met. Such players shall also be classified as Official Players and have to be registered by their respective National Federations.
4. Other than Official Players, all other players shall be classified as Additional Players. All other persons other than players or the Accompanying Official shall be classified as Accompanying Persons. A Federation may register any number of Additional Players and Accompanying Persons but they shall be responsible for their

own costs.

5. In order to provide appropriate tournament conditions, the Federations must complete the official online registration form, in full, and submit to the organising committee by no later than 17 July 2014.
6. FIDE endorsed Chess Academies may register not more than one player per age group per gender per event.
7. No players will be paired until all the payments have been made in full to the organisers.

8.8 Information Management

In our quest to be more efficient in the management of information, all information will be communicated and submitted electronically and it is therefore essential that your appointed Federation coordinator has access to the internet and e-mail. Access control is the responsibility of each Federation. More details on information management will follow.

8.10 Arbiter Applications

All applications must be made via the tournament website. Once the deadline has passed, the names of those applicants will be forwarded to FIDE for ratification. ONLY names registered via the website will be considered.

8.11 Certificates of Participation

All players and arbiters will be given certificates of participation. Certificates will be according to official registration details. Certificates will be printed before the tournament and therefore no changes will be allowed after the closing of the registration.

8.12 Stands

1. Anyone who wishes to rent a promotional stand on location should contact the organisers for rental conditions.
2. No one (except FIDE) will be allowed any promotional space or to have a stand for merchandise or other services, without written approval of the Organising Committee.

8.13 Arbiters

The following process will be followed to appoint arbiters:

1. All applications must be made via the tournament website.
2. Arbiters must have the approval of their federations to apply.
3. Once the deadline has passed, the names of those applicants will be forwarded to FIDE for ratification.
4. Only names registered via the website will be considered.
5. Arbiters will be informed in writing of successful or unsuccessful application.

10. Tournament

10.1 Format

1. The latest FIDE Rules and Regulations will apply.
2. Please refer to the tournament rules for the complete set of rules. Below is a summary which can be used for planning purposes.
 - a. Age Groups : u/8, u/10, u/12, u14, u/16, u/18
 - b. Format: Swiss System
 - c. Rounds: 11 rounds
 - d. Time Control: 90 minutes for the first 40 moves;
Followed by 30 minutes for the rest of the game;
30 seconds per move starting from move one.
 - e. Tie Break:
 - i. Direct encounter between the tied players (applies only if all tied players have palyed each other)
 - ii. Buchholz Cut 1
 - iii. Buchholz
 - iv. The greater number of games with Black (unplayed games shall be counted as played with White)
 - v. The greater number of wins
 - f. The national rankings will not be taken into account for pairings.

10.2 Clothing

All players are expected to play the 1st round and the last round in their national colours.

10.3 Volunteers

1. The 2014 World Youth Chess Championships needs a number of volunteers to be able to host the event, with the volunteers playing a



fundamental role in the organisation.

2. The registration for volunteers is now open, and we welcome applications from interested parties from age 18 upwards.
3. At this stage the registration form only requires a name, email address and telephone number. 10.4 Appeals

1. The Appeals committee will consist of 5 members and two reserves.
2. FIDE shall appoint three members
3. The rest of the members will be appointed at the Technical Meeting.
4. A protest against the decision of an Arbiter must be submitted in writing to the Chief Arbiter, within two hours after the end of the playing session.
5. A protest fee of R3 200.00 shall be payable to FIDE which is refundable if the protest is upheld. The Appeals Committee may also decide to refund the fee if it considers the appeal was not frivolous.
6. The decision of the Appeals Committee is final, binding and takes effect immediately.
7. The Appeals Committee shall keep a record of all proceedings and will submit a final report to FIDE.

10.5 Tournament Bulletin

1. There will be two bulletins daily:
 - a. General Bulletin with important information and
 - b. Special Bulletins for each group containing games;
2. The General Bulletin will be free.
3. Special bulletins will be at a fee.

10.6 Anti-doping

The event shall comply with IOC and FIDE doping control and testing regulations.

10.7 Prizes

1. The final ranking order of the players is determined by the number of points scored
2. If at the end of the tournament two or more players are tied for the first place or for any prize, the tie shall be broken as in accordance with the published tie-break regulations.
3. Three best Federations, by ranking of medals collected in all categories, will receive a trophy. For first place the number of gold medals will be taken under consideration, if there is a tie, then the number of silver medals, if there is still a tie, then the number of bronze medals. If finally this is still equal, then the total points of medallists will be taken for tie-break.
4. Top three places in each tournament will be awarded with trophies and medals.
5. There will be special gifts for the places from 4th – 8th.
6. Prize Giving Ceremony will be a celebration, open for anybody with accreditation.
7. There will be special gifts:
 - b. Youngest boy in the tournament;
 - c. Youngest girl in the tournament;
 - d. Most liked photograph on the official face book page;
 - e. Most brilliant game;

12. General

12.1 Currency

1. The local currency is South African Rand (ZAR).
2. Coins come in denominations of 5c, 10c, 20c, 50c, R1, R2 and R5
3. Notes come in denominations of R10, R20, R50, R100 and R200
4. Travellers' cheques can be exchanged in banks, bureaux de changes and some hotels. It is suggested you bring them in hard currencies.
5. Money can also be withdrawn at automated teller machines (ATM) of which there are many countrywide.
6. All major credit cards are accepted at all reputable outlets, retail stores and restaurants.
7. US\$ is equivalent to R10.90 at the current exchange rate.
8. € is equivalent to R15.00 at the current exchange rate.

12.2 Electricity

1. The standard voltage in South Africa is 220 Volts.
2. The South African electricity supply is 220/230 volts AC 50 HZ.
3. Most plugs are 15 amp 3-prong or 5 amp 2-prong, with round pins. If an adaptor is called for, consider bringing one with you, although they can be purchased locally.
4. US-made appliances may need a transformer.

12.3 Weather

- Durban has a warm, sub-tropical climate, with temperatures moderated by the expanse of the Indian Ocean. The average temperature in September ranges from 15°-25° C. We propose that all participants bring a rain coat and/or protective clothing for cooler days.
- The climate is described as all-year-round tourist-friendly. Sea temperatures are also relatively stable, averaging 21 degrees all year, providing possibilities for a diversity of aquatic activities in any season, including diving, fishing, swimming, boating and surfing.

12.4 Drinking water

- Water in South Africa is safe to drink and cook with when taken from taps in urban areas. Not all tap water in rural areas is safe for consumption, so take precautions if necessary.
- The Department of Water Affairs and Forestry maintains that South Africa's national standard of water quality compares well with World Health Organisation standards.
- Bottled water is available at all stores.

12.5 Telecommunications

1. For outgoing international calls, dial 00 plus the country and area codes of the destination concerned. Refer to telephone directories for international dialling codes, or obtain 24-hour assistance by calling 10903.
2. For incoming international calls, the code is +27 followed by the city code or cell phone code, dropping the first 0.

12.6 Smoking

1. There are stiff penalties associated with anti-smoking legislation in South Africa, including hefty fines for both the smoker and venue operator.
2. Be aware that smoking is banned on all domestic flights in South Africa; in all airport terminals; all restaurants, pubs and offices with no designated smoking areas; on all public transport; in cinemas and shopping malls; and even in some hotel rooms (check on booking)

12.8 Safety

1. The LOC will take the utmost precautions to ensure the safety of the players and accompanying persons.
2. General safety
 - a. Crime in South Africa, like many other places in today's world, can be a problem, but all you need to do is take the usual sensible precautions and follow some basic safety rules.
 - b. Know where you're going before you set off, particularly at night, watch your possessions, don't walk alone in dodgy areas, and lock your doors at night.
 - c. And, like anywhere else, there are some areas of the major cities that are known to be more risky than others. It is easy to avoid these and still have a good time.
 - d. If you cannot avoid such areas, then don't wear visible jewellery or carry cameras and bags over your shoulder. Limit the amount of money you carry on you and keep mobile phones and wallets tucked away where no one can see them.
 - e. Check beforehand that the areas you plan to visit are safe by asking hotel staff or police.
 - f. Other sensible advice is not to hitchhike, or don't accept or carry items for strangers.
3. Vehicle safety
 - a. When driving a private vehicle, either borrowed or hired, take some simple precautions to avoid car hijackings or "smash-and-grabs".
 - b. As a driver, be on the alert when coming to a halt at traffic lights or stop streets, as well as when arriving at or leaving any premises. Car doors should always be locked, and valuables are better kept in the boot or under the seats.

- c. Plan your route beforehand. Make sure the map you consult is a current one. When parking at night, choose well-lit or security-patrolled parking areas.
- d. Street security guards will usually ask whether they can watch over your car, and in return should be paid a small fee – anything from R5 upwards.
- e. Only use reputable tour operators and travel and transport services. If you're not sure, ask your hotel to recommend a service provider for you or contact the National Tourism Information and Safety Line on +27831232345.

4. ATM safety

- a. When using automatic teller machines (ATMs) in South Africa, practice the generally accepted safety precautions you would employ when at home.
- b. Never accept an offer from a stranger to help you with your transaction. Be alert and watch that no one steals your card when you turn your back.
- c. If your ATM card is withheld by the machine, approach the bank to release it, or call the helpline number that can be found at the ATM.
- d. When using a credit card in restaurants, ask the waiter to bring a portable credit card machine to your table.
- e. Report stolen or lost cards immediately.

5. Hotel safety

- a. Never leave your luggage and other possessions unattended. Know where your things are.
- b. Remember to store valuables in the safety deposit box and keep your room locked at all times.
- c. Don't leave your room keys lying around; rather hand the key in at the desk when you leave.

- d. Emergencies: Dial 10111 from a landline for the police and briefly explain what happened. This call is free from any phone box or landline. If you are using a cellular phone dial 112 and your call will be transferred to the appropriate emergency service.
 - e. If you're in your hotel room, contact the emergency number provided or the front desk.


13.2 uShaka Wet 'n Wild
