Nauru Chess Federation Constitution

1. Name

The federation will be called Nauru Chess Federation and will be affiliated to the Fédération Internationale des Échecs, FIDE.

2. Aims and objectives

The aims and objectives of the federation will be:

To offer coaching and competitive opportunities in chess.

To promote the federation within the local chess community.

To ensure a duty of care to all members of the federation.

To provide all its services in a way that is fair to everyone.

3. Membership

To ensure all present and future members receive fair and equal treatment. Membership should consist of officers and members of the federation. All members will be subject to the regulations of the constitution and by joining the federation will be deemed to accept these regulations and codes of practice that the federation has adopted.

Members will be enrolled in one of the following categories:

Full member.

Junior member.

4. Membership fees

Membership fees will be set annually and agreed by the Executive/ Management Committee or determined at the Annual General Meeting. Fees will be paid: annually.

EDERATIO

5. Officers of the federation

The officers of the federation will be:

President.

Vice President

Secretary.

Treasurer.

Officers will be elected annually at the Annual General Meeting.

All officers will retire each year but will be eligible for re-appointment.

6. Finance

The Federation Treasurer will be responsible for the finances of the federation. The financial year of the federation will end on: 31st July.

7. Annual General Meetings

Notice of Annual General Meetings (AGM) will be given by the Federation Secretary. Not less than 21 clear days notice to be given to all members. The AGM will receive a report from officers of the Management Committee and a statement of the accounts. Elections of officers are to take place at the AGM. All members have the right to vote at the AGM.

8. Discipline and appeals

All complaints regarding the behaviour of members should be presented and submitted in writing to the Secretary. The committee has the power to take appropriate disciplinary action including the termination of membership.



9. Dissolution

A resolution to dissolve the federation can only be passed at an AGM through a majority vote of the membership.

10. Amendments to the constitution

The constitution will only be changed through agreement by majority vote at an AGM.

11. Declaration

Nauru Chess Federation hereby adopts and accepts this constitution as a current operating guide regulating the actions of members.
