RESOLUTION OF THE FIDE PRESIDENTIAL BOARD ON THE FAIR PLAY COMMISSION

1. The Presidential Board resolves to change several provisions with respect to Fair Play Commission regulations and to amend them as per this Resolution.
2. The Presidential Board resolves to amend Clauses 4.7 – 4.16 of the Non-Elected Commission Regulations as specified below:
 - 2.1. Clause 4.7 to be amended as follows:

“4.7. The FPC shall consist of full members (with full voting rights) and consultative members (in a consultative capacity only). The total number of the FPC members shall be decided by the Presidential Board”
 - 2.2. Clause 4.8 to be amended as follows:

“4.8. The Chairperson and the Secretary of the FPC shall be appointed by the President”
 - 2.3. Clause 4.10 to be deleted.
 - 2.4. Clause 4.12 to be amended as follows:

“The period of appointment shall be 4 years commencing right after the session of the GA devoted also to the elections of FIDE Officials. Upon a proposal from the Chairperson of the Commission the Presidential Board has the right, at any time, to terminate the powers of, or replace, a consultative or full member other than the Secretary.”
 - 2.5. Numeration of Clauses 4.7 – 4.16 to be changed accordingly.
 - 2.6. Clause 4.16 to be added as follows:

“4.16. Should there be any discrepancies between the general rules and regulations specified in any FIDE rules and regulations (except for the Statutes) regarding the Fair Play Commission, the specific rules on the FPC shall prevail”
3. The Presidential Board resolves the following with respect to the FPC membership:
