## 9. Change of Statutes

According to the decision of the extraordinary General Assembly 2009 in Kalithea, Greece a working group led by Geoffrey Borg has drafted a new version of the ECU Statutes (annex1).

#### 10. Amendment of the ECU Tournament Rules

According to the decision of the extraordinary General Assembly 2009 in Kalithea, Greece a working group has drafted an amendment of the Tournament Rules regarding the bid procedure (annex 2). In addition there is a motion of the Board concerning "Standards for ECU Tournaments" (annex 3).

The extraordinary General Assembly 2009 in Kalithea, Greece has determined that all the bids should be evaluated according to the bidding procedures, guidelines and tournament regulations in force and will be awarded by this General Assembly.
